Electronic Travel Authorisation (NZeTA)

Travelling to New Zealand - New Zealand Customs Service

From 1 October 2019, visitors from <u>visa-waiver countries</u> must request a New Zealand Electronic Travel Authority (NZeTA) before travelling to New Zealand. Eligible visitors must apply and receive an NZeTA prior to their intended departure date or will not be able to board a flight to New Zealand. This is not a regulation created by airlines. It is a requirement of the New Zealand Government, and unfortunately, where passengers who are eligible and do not have a travel authorisation, boarding will be denied. Airline check-in staff will not be able to resolve the problem. Nor will Skimax be liable for any costs or cancellation penalties or inconvenience where travellers do not have a travel authorisation and are not permitted to travel. To avoid potential disruption and in the event of denied boarding, please be aware of this requirement now and make sure the authorisation procedure is adhered to.

If you are travelling to New Zealand on a New Zealand or Australian passport you will **<u>NOT</u>** be required to apply for a NZeTA.

If you are living in Australian without an Australian Passport you <u>WILL NEED</u> to apply for a NZeTA.

- If you are from a visa waiver country you must hold an NZeTA before you travel. **Things to note**
 - Allow up to 72 hours for processing, but it could take as little as 10 minutes.
 - NZeTA cost from NZD17.
 - You pay an International Visitor Conservation and Tourism Levy (IVL) at the same time as your NZeTA..
 - Once you have requested an NZeTA you can check its status.

NZ Travel Declaration (NZTD)

What you need to know

- Everyone entering New Zealand needs to submit a declaration.
- It is free and takes about 10 minutes.
- You can do it on the NZTD app or online form, using your phone or computer.
- For air travellers, the earliest you can submit your declaration is 24 hours before you start your trip to New Zealand. It needs to be submitted by the time you reach passport control in New Zealand.
- Someone you trust can help you fill it in or do it on your behalf (with your permission).
- A declaration needs to be completed for each traveller, including babies and children.
- Your digital declaration is linked to your passport and is checked when you arrive at the eGate or by a border officer. There is no QR code issued and you don't need to print anything out.
- There is a paper declaration form available, for travellers who cannot complete it online.
